主旨:有關WTO環境商品協定(EGA)談判本局擬研提我國具產業優勢 競爭項目建議商品清單一案,請 貴公(協)會協助提供利基 型環境商品建議清單,請 查照。



### 說明:

訂

- 一、2012年9月APEC經濟領袖會議通過54項APEC環境商品清單,並協定各會員體於2015年底前將該等商品之執行稅率降至5%或以下。美國依其2013年6月提出對抗氣候變遷行動計畫,聯合歐盟等立場相近會員國,推動WTO環境商品協定(EGA)複邊談判。
- 二、我國與美國等14個會員國於本(103)年1月瑞士達沃斯(Davos)舉辦世界經濟論壇期間,共同發表環境商品聯合宣言,以54項APEC環境商品為共識基礎,共同推動WTO環境商品複邊談判。願共同推動環境商品進一步自由化,包括擴大環境商品範圍、更有企圖心之降稅模式等;在參與成員達關鍵多數時,提供所有WTO會員最惠國待遇。
- 三、WTO環境商品協定(EGA)談判已於本(103)年7月8~10日完成第一回合談判,由我國等14個WTO會員於日內瓦發表聯合聲明,

宣布談判正式啟動,並規劃後續談判期程及討論環境商品清單共識類別包括空氣污染管制、固體及有害廢棄物管理、潔淨與再生能源、廢水處理、環境監測、分析設備及其他類別如綠建築、能源管理、降噪減震等(如附件1)。

四、配合上述談判期程規劃,本局擬提交我國具產業優勢競爭項目建議商品清單,請 貴公(協)會廣為研提貴管產業之利基型商品項目(格式如附件2),本局將彙整並研析其適切性後,提供本國代表團於談判時之參考,以爭取納入WTO環境商品協定(EGA)談判降稅項目,帶動我國綠色產業發展,創造龐大綠色商機。
